



## AGREEMENT FOR USE OF ATLANTA FLAMES PRACTICE FACILITY

The DeKalb County School System has graciously allowed use of this gym. Therefore, any misuse of this property may jeopardize everyone's access to this facility. For that reason, we ask you to assume responsibility for the treatment of this facility and equipment by your players, parents and other coaches, while you are at the facility. Specific requirements and considerations:

1. Payment for use of the facility is in advance.
2. A parent or guardian for each player using this facility must sign the Player's Hold Harmless Agreement prior to their use of the facility. Please email the original executed Agreement to [flamesfastpitch@comcast.net](mailto:flamesfastpitch@comcast.net) and keep a copy of the Agreement for your files.
3. You are expected to honor your time commitments. For example, if you agreed to use the facility from 5:00 pm to 7:00 pm:
  - a. Ensure someone is at the facility **AT** 5:00 pm so we know the facility is not left unattended.
  - b. When your time period has expired, please allow the next user to begin use immediately.
  - c. If you are the last user for that day, please turn off the lights & fans, close every door and ensure the facility is locked.
4. Cleanup: Please leave the facility as you found it – or better. All trash should be picked up and placed in receptacles. Please check and clean up the restrooms before you leave. Do not allow your players to eat sunflower seeds or similar products. Offenders will be responsible for the \$50.00 cleaning fee.
5. If you, your players or coaches damage the facility, you will be responsible for the cost of repairs. Please inform us of any damage you may discover upon entering the facility.
6. Players and others using the facility during your time are your responsibility. Do not leave players or minors in the facility without a coach or parent present at all times to supervise them.
7. Private instruction - In the best interest of all involved, when instructors or coaches are giving individual lessons to a minor, please require a parent to be present at all times.
8. No alcohol or tobacco products are allowed on the premises.
9. NO CLEATS are allowed in this facility.
10. Finally, safety is paramount, especially for our young players. Please supervise and ensure:
  - a. Catchers are expected to use appropriate safety equipment when catching pitchers.
  - b. Batters must wear helmets unless: (a) hitting off a tee; or (b) hitting soft toss.
  - c. At least one coach (or parent) per 5 players is running drills during a practice.
  - d. No more than 15 players will be participating in practice at one time.

Your help keeping this facility safe and clean is greatly appreciated and ensures The Flames can continue to keep it open for you and others. Thank you.

The undersigned further represents that they have adequate insurance in place to cover the cost of any injury or damage to person or property sustained by Player while using the Facility and that they understand that Releasees have relied upon this representation as a condition to entry to the Facility.
